WE DO HEREBY COVENANT AND AGREE, as property owners of lots or parcels that are connected to the shared house connection sewer, to be jointly responsible for the maintenance, repair, removal and replacement of the house connection sewer in the public Right-of-Way and private easements.

WE FURTHER AGREE to indemnify and hold harmless the City of Los Angeles for granting the owners of the multiple lots or parcels the right to construct and/or connect to the shared house connection sewer.

WE FURTHER AGREE that this Covenant and Agreement is made for the direct benefit of each of the properties described herein.

This Covenant and Agreement shall run with all of the above described land; be binding upon ourselves and future owners, encumbrances, successors, heirs or assignees; AND, continue in perpetuity until released by the authority of the City Engineer of the City of Los Angeles upon submittal of request, applicable fees and evidence that this Covenant and Agreement is no longer required by law.
