Jobsite conditions must comply with the latest edition of the "Work Area Traffic Control Handbook" (WATCH). 5. Barricades and lights must be in use at the jobsite from the start of removals to the completion of work. 6. All work shall comply with latest edition of the "Greenbook", Standard Specifications for Public Works Construction. 7. Slurry cement backfill is required in all public streets and alleys. Lateral require Public Works inspection before backfill is placed. 8. Only Bonded Sewer Contractors are permitted to work in the public right-of-way. 9.
