### WORK DESCRIPTION

To promote bike usage, this project will upgrade approximately 750 existing roadway grates to bike safe grates near or along bike paths, bike lanes, and bike routes as well as transit hub areas throughout the City. This project will improve safety access, reduce traffic congestion, reduce air pollution and promotes the use of bicycling as a viable form of non-motorized commuter transportation as directed in the City of Los Angeles.
